ZONING VARIANCES**

WHEREAS, the Board of Supervisors of Juniata Township has determined it necessary to collect certain fees for directly rendered services, and

WHEREAS, such fees offset the expenses incurred by the Township relating to such services, and

WHEREAS, such fees must stay current to effectively cover the related expenses, and

NOW THEREFORE, BE IT RESOLVED AND ENACTED, by the Board of Supervisors of the Township of Juniata, Huntingdon County, Pennsylvania, that the Fee Schedule in relation to Exhibit "A" is hereby established, updated, and/or revised, and is otherwise hereby adopted, for such permits, inspections and fees and in such amounts as are set forth and specified in the forms attached hereto collectively as Exhibit "A," which Exhibit is incorporated into this Resolution hereby.

It is further **RESOLVED** that any currently existing and/or collected fee, assessment, and/or cost of the Township that is not set forth and/or specified in this Resolution is hereby affirmed and/or adopted, and the same shall continue to exist, and shall continue to be imposed, charged, assessed, and/or otherwise collected by the Township, in the amount and in the manner as exist on the date of the adoption of this Resolution.
