Chairman Stein called the meeting to order at 6:00 p.m. at the Juniata Township Municipal Building and led the meeting in the Pledge of Allegiance.

Reading and approval of the regular meeting minutes from the monthly township May 09, 2023 meeting.

Supervisor Parks motioned to accept the minutes as recorded for this meeting. Seconded by Supervisor Stein. Unanimously approved by the Board.

The financial report was presented. Supervisor Parks motioned to approve the financial report as recorded for this meeting. Seconded by Supervisor Stein. Unanimously approved by the Board.

# • Engineer Report

- Tom reported the Roby lot merger plan was refiled, based on Tom's review comments, with revisions to the Huntingdon County Planning Commission.
- Payne/Urban Ranch planning module was filed on behalf of the township on June 9, 2023, with the DEP Altoona office.
- Examined a flood plain review, prepared by Josh Gunnett, for Savino on Point Road.
- Tom examined the document and discussed some items with Gunnett. Request is still under review.

#### Solicitor Report

- Solicitor Bradburn reported that several months ago the Board of Supervisors enlisted insurance council to represent the township in the matter of Stewart vs. Ridgeview Campground and Juniata Township.
- Preliminaries hearings were filed by all parties. Oral arguments are scheduled for June 26, 2023 @ 1:00 p.m.
- Recommended at last meeting that the Board of Supervisors accept the resignation of Wilbur Hall, Jr. effective May 15, 2023. Unfortunately, Wib passed away on May 12, 2023.
- Advertised in the Daily News for residents interested in the vacant supervisor position.
- Bradburn referred back to an issue brought up by Justin Stoner at last month's meeting regarding a commercial business owned by Carl Grove that may or may not be conducting business out of a new home being constructed by Grove. At this time, the Board of Supervisors consider this issue to be dormant because the project is currently under construction. If in in the future there is a commercial business being run out of the home, then Grove would have to comply with the Juniata Township SALDO.
- Stoner asked if the Supervisors could include a clear definition of a commercial business in the SALDO.

Supervisor Stein took a moment to remember, Wilbur Hall, Jr., who served as a Juniata Township Supervisor for over 40 years. Supervisor Stein stated that Wib's passing is a tremendous loss for the township.

#### **NEW BUSINESS**

• Vacant Supervisor Seat - Appointment until December 31, 2023

- Supervisor Stein asked for any persons interested in the position to please step forward. Tim Brown and Duane Dysard both expressed interest in the position.
- Supervisors conducted a brief interview with each candidate. After the interviews, Supervisor Stein and Parks agreed that both Brown and Dysard were qualified for the position.
- Supervisors ultimately decided to appoint Tim Brown to fill the vacant seat until 12/31/2023. If Brown would like to continue in the position after 12/31/2023, he will have to run a write in campaign for the position in the November election.

Supervisor Stein motioned to appoint Tim Brown to the vacant Juniata Township Supervisor position until 12/31/2023. Seconded by Supervisor Parks. Unanimously approved by the board.

 Arrangements will be made to have Brown sworn in to the position of Juniata Township Supervisor.

#### MAY 2023 ACTIVITY REPORT FOR JUNE 2023 MEETING

<u>**Ridge View Campground</u>**- The time doseing panels were installed and final inspection was conducted. The septic system went online May 26<sup>th</sup>. Preformed setback checks for the shower house and the playground.</u>

<u>Mark Savino, 11263 Point Rd.</u> - Submitted the flood way application through his Gunnett engineering. Sent on to Tom Lavine for review and comment.

<u>Charles Mangas 8561 Awkerman Rd.-</u> Mr. Manges wants to replace his seasonal porch with a new porch and also do some interior renovations to accommodate handicap access. The property is located in the flood way. I told him to contact an engineer to help with the paperwork needed for the permitting. I sent his engineer a copy of the flood ordinance.

Brian Chrisemer, 12537 Piney Ridge Rd.- Obtained a permit from Bureau Veritas to turn the cabin into residential status. He has reported that he is close to be complete with the required modifications and will present the occupancy permit when they are

Lisa Adams- Henderson / Overlook Rd.-I received a call from Mrs. Adams. They want to turn their car port into a "Florida Room" living space. I explained to them again that the lot is non-building status and must be served by septic to accommodate any living quarters. In order to obtain building status some form of planning would be required. They currently have a single camper on site they use in the summer.

Shrack Realty / Ryan Sample – 12163 Henderson Overlook Rd.- I received a call about the property that is for sale and under contract. The home inspector found a possible issue with the septic system. I visited the site and found no regulator malfunction. The inspection report was inadequate, and I recommended that they have a PSMA test completed to judge the health of the septic system.

Timothy & Heather Caracciolo 12345 Henderson Overlook Rd.,- The trailer was removed and they replaced it with one camper.
