Reading and approval of the regular meeting minutes from the monthly township October 10, 2023 meeting.

Supervisor Parks motioned to accept the minutes as recorded for this meeting. Seconded by Supervisor Brown. Unanimously approved by the Board.

• Engineer Report - Tom Levine

Point Road

- Tom reported that he has prepared an LSA Grant application for the repair of 300 feet of Point Road with retaining wall system for \$264,045. The grant requires no match from the township but is highly competitive.
- Tom presented a Commonwealth Finance Authority resolution to be signed by Secretary McDermott to proceed with the grant.

Supervisor Parks motioned to authorize Secretary McDermott to sign the resolution. Seconded by Supervisor Brown. Unanimously approved by the Board.

Solicitor Report – Wayne Bradburn

Hazardous Material Spill

 Cincinnati Insurance Company has reimbursed the township for out-ofpocket costs incurred related to the spill.

Jeremy Eichelberger

- Wayne sent Eichelberger notice of potential violation.
- The postal service has tried to deliver the notice twice with no success.
 The postal service will only try to deliver one more time.
- Township may want to consider hiring a constable to deliver the notice to Eichelberger if the third attempt to deliver by the post office fails.

Supervisor Parks motioned to have Solicitor Bradburn hire a constable deliver the notice to Eichelberger if the third attempt to deliver by the post office fails. Seconded by Supervisor Brown. Unanimously approved by the Board.

Stewart Litigation

 Spoke with Matthew Vodzak, township's insurance council, in regards to the Stewart litigation. Vodzik informed Bradburn that the matter remains in the pleading and discovery stage.

PUBLIC FORUM

Payne - Urban Saddle Ranch

- Robert Payne does not feel that the STR Ordinance applies to his business based on the language in the ordinance.
- In Section 2b of the ordinance it states that the chapter does not apply resorts, camps, hotels, motels and bed and breakfasts, which is what Payne operates.
- Ordinance also states that it applies to residential rentals, not commercial.
 Payne's property is commercial.

- Solicitor Bradburn read the definition of dwelling unit which is a building or portion thereof providing complete housekeeping facilities for one family or a group of unrelated persons using such facilities.
- Solicitor Bradburn also read definition under section 7b of the ordinance which states that for multiunit buildings and multiunit dwellings on one parcel of land having common and appropriately sized and approved water and sewage systems one short-term rental permit shall be required.
- Referring to Payne's website, Solicitor Bradburn stated that Payne's property clearly meets the definition of a dwelling unit and will need to comply with the Juniata Township Short-Term Rental Ordinance.

NEW BUSINESS

2024 Budget

 Secretary McDermott presented the 2024 Budget to the board of supervisors for approval and advertisement.

Supervisor Parks motioned to approve and advertise the 2024 Budget to be adopted at the December 12, 2023. Seconded by Supervisor Brown. Unanimously approved by the Board.

• Hazardous Material Endorsement

- Secretary McDermott presented a quote from Brown & Walters
 Insurance Company to add a hazardous material endorsement to the
 township insurance coverage for a premium of \$2,525.00 per year.
- Solicitor Bradburn recommended adding the endorsement to township's insurance coverage.
- Supervisor Brown and members of the public feel that the main exposure to the township comes from sub-contractors. Therefore, instead of the township carrying the insurance, the township would just need to require that all sub-contractors carry the insurance.
- Supervisors agreed to table a decision until December's meeting until more information can be gathered.
- Secretary McDermott will provide Solicitor Bradburn with insurance agent contact information to gather additional information.
