Chairman Stein called the meeting to order at 6:00 p.m. at the Juniata Township Municipal Building and led the meeting in the Pledge of Allegiance.

Reading and approval of the regular meeting minutes from the monthly township February 13, 2024 meeting.

Supervisor Parks motioned to accept the minutes as recorded for this meeting. Seconded by Supervisor Grove. Unanimously approved by the Board.

The financial report was presented. Supervisor Parks motioned to approve the financial report as recorded for this meeting. Seconded by Supervisor Grove. Unanimously approved by the Board.

## • Engineer Report - Tom Levine

#### PUBLIC FORUM

#### Justin Stoner

- Justin sent the township an example of a form for contracts that the township could utilize for hiring contractors along with an example of insurance limits that are often requested.
- At the last meeting, a discussion was held about Penn Township's STR applying to campgrounds that rent out campers. Justin made an inquiry and found that STR's do not apply in Penn Township to campgrounds. Although, cabins in a campground are not exempt from STR.
- If a camper is used as an Air BNB, then it would fall under the STR.
- There are several camper rental companies that bring campers to a campground and set them up for rent. There is no sure way to track these rentals.
- Supervisor agreed more discussion is needed on this issue to determine a way to track all STR's.

## **NEW BUSINESS**

## Amusement Tax Ordinance Revisions

- Two versions of the ordinance were presented to the Board of Supervisors.
  - Version one stated that each applicant pays a yearly permit fee of \$100.00
  - Version two stated that each applicant pays a one-time permit fee of \$100.00 for the life of the owner of the property.
  - Both versions changed the remittance requirements from monthly to quarterly.
  - Chairman Stein stated that he is still opposed to the yearly permit fee.
     Supervisor Grove disagreed stating the township would lose money by not requiring a yearly permit fee.
  - Supervisor Parks expressed concern about the one-time permit will allow permit holders to possibly violate the ordinance. Supervisor

Stein stated that in the ordinance the township has the right to revoke the permit at any time for violations.

Supervisor Stein and Parks voted no to the version with the \$100.00 yearly fee. Supervisor Grove voted yes. The motion failed by a 2-1 vote.

Supervisor Stein made a motion to accept the version requiring that applicants pay a one-time permit fee of \$100.00 for the life of the owner of the permitted property. Seconded by Supervisor Parks. Supervisor Grove voted no. The motion carried by a 2-1 vote.

Supervisor Parks motioned to advertise the revised ordinance for the public hearing. Seconded by Supervisor Grove. Unanimously approved by the board.

#### REPORTS

#### STR Enforcement

- 14 short-term rental properties have been issued.
- 3 properties are in the permitting process. Tammy needs to get with Jamie on the septics.
- Mike Fedash has not submitted anything as of yet. Tammy contacted Mr. Fedash and he assured her that she would have something to her this week.
- Tackling campgrounds with cabins is next on Tammy's list.
- Jamie asked about pumping reports for STR septic systems. Tammy will send Jamie a list.

## Construction Code Enforcement (see attached report)

- Savino flood plain have not heard anything for 6-8 months. Jamie will reach out to engineers for an update.
- Wagner campers on Baja Drive no contact from Wagner. Jamie will send Wagner a letter giving him 30 days to get an engineer on board.

Supervisor Stein motioned to have Jamie send Wagner a letter giving him 30 days to get an engineer on board to start working towards creating a campground. Seconded by Supervisor Parks. Unanimously approved by the board.

Jamie advised the Supervisors to address solar farms and put controls in order before solar farms come to the township. Solar farms are noisy, unsightly, creates a glare and the lithium batteries can be hazardous. Jamie provided the township with an example solar farm ordinance.

## Roadmaster/Supervisor Report

- Ditches cleaned on Crestwood, River Road, Stonebridge, Henderson Hollow.
- Started D&G in kind work by trimming trees and cleaning brush.
- Whitsel's Excavating submitted a list of equipment along with pricing for equipment and operators.
- Whitsel's pricing is \$90.00/hour for any small equipment with operator and \$95.00/hour for a grader with operator.
- To grade both sides of Point Road, Stone Bridge Road, Bakers Hollow, Henderson Overlook and over the top of the Mountain to turn around which approximately 10.37 miles, it would cost approximately \$2,280 for 3 days to have Whitsel to complete the work. Additional costs to include township labor which will be needed for traffic control and operating township equipment needed for the project.
- Butch would also like have Whitsel roll River Road.

Supervisor Parks made a motion to hire Whitsel's Excavating to complete the grading project and roll River Road on the condition that Whitsel has proper insurance coverage. Seconded by Supervisor Grove. Unanimously approved by the board.

Service truck is inspected and ready to go.

#### **OLD BUSINESS**

## Badging of Township Equipment

 Chairman Stein obtained pricing from U.S. Municipal and WCS Signs for vehicle badges. U.S. Municipal quoted \$240.00 and township would have to install signs. WCS Signs quoted \$265.00 which includes removal of old badges and installation of new.

Supervisor Parks motioned to purchase the truck logos from WCS Signs for \$265.00. Seconded by Supervisor Grove. Unanimously approved by the Board.

## Gas Powered Tamper

 Chairman Stein obtained a quote for a gas-powered tamper that is needed for the Dirt & Gravel project. The cost of tamper is \$2,200 from Pristows. Supervisor Grove motioned to purchase the tamper from Pristows for \$2,200.00. Seconded by Supervisor Parks. Unanimously approved by the Board.

## Road Resurfacing

 Chairman Stein reported that the township needs to get started on road resurfacing. Chairman Stein proposed contacting Penn Dot for pricing and bidding information.

Supervisor Parks motioned to have Chairman Stein contact Penn Dot to proceed with road resurfacing project. Seconded by Supervisor Grove. Unanimously approved by the board.

#### Hazardous Material Insurance Endorsement

 Supervisors have decided not the pick up the hazardous material insurance endorsement instead the township will require all contractors to have adequate insurance coverage.
